ORDINANCE NO. 268-01

AN ORDINANCE REGULATING THE COLLECTION AND DISPOSAL OF ALL
GARBAGE, LITTER, RUBBISH, SCRAP METAL APPLIANCES AND USED
BUILDING MATERIALS WITHIN THE VILLAGE OF FELICITY

BE IT ORDAINED by the Council of the Village of Felicity, Clermont County, Ohio,
at least a majority of its members concurring:

SECTION 1. Definitions

“Garbage” shall include every waste or refuse animal, fruit or vegetable matter, liquid or otherwise, that attends the preparation, use, cooking, dealing in, or storage of meat, fish, fowl, fruit, or vegetables.

“Litter” shall include cans, paper, furniture, furniture parts, and motor vehicle parts including tires and appliances which are unfit for further use due to defective, or missing parts.

“Rubbish” shall mean and include foods, wire, chips, shavings, bottles, broken glass, crockery, tins, cast or wooden ware, boxes, rags, dead tree parts, paper, circulars, handbills, boots, shoes, ashes, and other waste materials other than garbage or offal.

“Used building materials” shall mean and include any materials such as wood, stone, brick, cement block, or any composition thereof used or useful in the erection of building or structure, which has been used previously for such erection or construction by the same person or other persons.

“Scrap metal” shall include pieces or parts of steel, iron, tin, zinc, copper, aluminum, or any alloy thereof, whether covered with porcelain or other materials, whether intact or in parts whether in it's original manufactured form or crushed, damaged, or compacted, and which can no longer be used for it's originally intended purpose.

“Regularly scheduled Waste Removal” shall mean the day specified for weekly scheduled waste removal – usually Monday of each week from 6:00 am to 6:00 pm.

SECTION 2. All garbage shall be kept in leak proof containers with a suitable lid to prevent spillage or entry of animals. All garbage, litter, rubbish, scrap metal, appliances, and used building materials to be picked up by a waste hauler shall be set out on the curb no earlier than 24 hours prior to regularly scheduled waste removal. All cans used for the collection of garbage, litter, rubbish, scrap metal, and used building materials shall be removed from the curb no later than 24 hours after the regularly scheduled waste removal.

SECTION 3. All abandoned appliances such as a refrigerator, ice box, freezer or similar device which is capable of being secured by a bolt or latch which can be operated only from the outside of such device shall have the door removed or the appliance door shall be made inoperative by securing the same.

SECTION 4. Any person found violating this ordinance shall be fined not more than \$100.00.
